

Social Partnership Agreement

Russia, St. Petersburg

June "03," 2026

The "Theosophy" Foundation for the Promotion of Socially Significant and Educational Activities, hereinafter referred to as the "Foundation," represented by its president, Alexander Sergeyevich Kuleshov, acting in accordance with the Charter, on the one hand, and "State Budgetary Preschool Educational Institution Kindergarten No. 27 of the Admiralteysky District of St. Petersburg," hereinafter referred to as "State Budgetary Preschool Educational Institution Kindergarten No. 27 of the Admiralteysky District of St. Petersburg," represented by Director Marina Arnoldovna Yakushenko, acting in accordance with the Charter, on the other hand, hereinafter collectively referred to as the "Parties," have entered into this Agreement on Social Partnership regarding cooperation on joint socially significant activities within the "White Jaguars" project, aimed at developing and promoting children's creativity.

1. Subject Matter of the Contract

The subject matter of this agreement is the social partnership mechanism between the Fund and "State Budgetary Preschool Educational Institution Kindergarten No. 27 of the Admiralteysky District, St. Petersburg," based on mutual interests.

2. Goals and Objectives of the Joint Initiative

The primary goal of social partnership is to collaborate on the development and implementation of socially significant activities aimed at fulfilling statutory objectives, engaging in joint initiatives, enhancing the culture of business interaction, and expanding social networks.

Objectives of social partnership:

- organizing socially significant events for regions of the Russian Federation and other countries around the world;
- ensuring the improvement of educational content and the organization of cultural and educational development;
- providing mutual services, participating in joint projects and other forms of collaborative activities that do not conflict with the law;
- providing informational, media, and resource support (mass media, online resources, and others);
- providing other possible support within the framework of implementing joint projects.

3. Main Areas of Activity

Cultural and Educational Activities:

- public cultural events (exhibitions, conferences, workshops, contests, etc.);
- socially significant projects;
- joint charitable initiatives.

4. Rights

The parties have the right to:

- provide technical and organizational assistance on mutually agreed terms;
- prioritize the exchange of information, provided that this does not conflict with previously assumed obligations;
- decline proposals if they are not economically viable;
- develop scenarios and hold joint public events.

5. Obligations of the Parties

5.1. The Parties agree to:

- 5.1.1. participate in the joint implementation of educational projects (events, projects, concerts, master classes, creative workshops, etc.) that foster an innovative and proactive professional environment.
- 5.1.2. participate in the development and implementation of plans and joint projects;
- 5.2.3. promptly inform each other of and coordinate plans and schedules for joint events;
- 5.2.4. engage in other forms of cooperation within the scope of their statutory activities.

6. Term of the Contract

6.1. This Agreement shall enter into force upon its signing by both parties.

6.2. The term of this Agreement is 1 year. Unless one of the parties provides written notice of its intention to terminate the relationship under this Agreement, it shall be deemed extended until such notice is received.

7. Final Provisions

This agreement is executed in two copies. Each party shall retain one copy.
