

Social partnership agreement

Russia, Saint Petersburg

February 27, 2026

The Fund for the Promotion of Socially Significant and Educational Activities “Theosophy”, hereinafter referred to as the “Fund”, represented by its president Alexander Sergeevich Kuleshov, acting on the basis of the Charter, on the one hand, and **PRIVATE INSTITUTE NGK EDUCATION LTD (No. 07.18.008.003.113)**, hereinafter referred to as “BRAVO Intellect School,” represented by General Director Iveta Vladimirovna Emelyanova, acting on the basis of the Charter, on the other hand, hereinafter jointly referred to as the “Parties,” have entered into this Agreement on social partnership in the field of cooperation on joint socially significant events of the “White Jaguars” project, aimed at developing and promoting children's creativity.

1. Subject matter of the agreement

The subject of this agreement is the social partnership mechanism between the Fund and "**BRAVO Intellect School**" based on mutual interests.

2. Goals and objectives of joint activities

The main goal of social partnership is cooperation in developing and implementing socially significant activities to achieve statutory objectives, joint activities, improving the culture of business interaction, and expanding the network of social contacts.

The objectives of social partnership:

organizing socially significant events for regions of the Russian Federation and other countries around the world;

- ensuring the improvement of educational content and the organization of cultural and educational processes;
- providing mutual services, participating in joint projects and other types of joint activities that do not contradict the law;
- provision of information, media, and resource support (media, Internet resources, and others); providing other possible support within the framework of joint projects.

3. Main areas of activity

Cultural and educational activities:

- cultural events (exhibitions, conferences, master classes, competitions, etc.);
- socially significant projects;
- joint charity events.

4. Rights

The parties have the right to:

- provide technical and organizational assistance on mutually agreed terms;

- to prioritize the exchange of information, provided that this does not conflict with previous agreements commitments made;
- decline offers if they are not economically viable develop scenarios and hold joint mass events.

5. Responsibilities of the parties

5.1 The Parties undertake to:

- 5.1.1 participate in the joint implementation of educational projects (events, projects, concerts, master classes, creative laboratories, etc.) that provide an innovative and proactive professional environment.
- 5.1.2 participate in the development and implementation of plans and joint projects;
- 5.1.3 inform and agree on plans and dates for joint activities in a timely manner;
- 5.1.4 other interactions within the scope of statutory activities.

6. Term of the agreement

- 6.1 The agreement shall enter into force upon its signing by both parties.
- 6.2 The term of the Agreement is 1 year. In the absence of written notification from one of the parties of their desire to terminate cooperation under the Agreement, it shall be deemed extended until such notification is received.

7. Final provisions

This agreement is made in two copies. Each party shall retain one copy.
